Information requested:

- A) I note that in one report the person alleged to have caused the hate incident seemed to have reported being attacked by staff with knifes. That should have been investigated by police and passed for inspection to a health inspectorate or watchdog. I would therefore at review request that all and any other information regarding persons allegedly attacking vulnerable patients with knifes is disclosed.
- B) I would be particularly interested in any information if it exists that may detail anti-Catholic sectarian instances or claims of such instances in which Catholics are described as being detained, institutionalised or otherwise pathologized or "medically treated" for their faith or beliefs or assumed faith or beliefs at the hospital. Or for claims they or other Catholics are being persecuted for their beliefs of assumed beliefs. If such exists.

Response:

A) We located two incidences that match your criteria. The first dates from 2003, the second has already been provided in our response to FOI/006/22.

B) We have not found any records that match your criteria using digital searches of our records.

We do have paper archives relating to the organisation and individual patient files that might hold information that could be within the scope of your request. To search this information we would need to manually review each file.

We estimate that there are over 2700 files that would need to be reviewed, each taking around 1 hour. The individual(s) that could conduct such a review, given the sensitive nature of these files, would need to be senior staff.

2700 files x 1 hour x £15 per hour = £40,500

This is in excess of the £600 upper limit set out in FOISA section 12(1) and as such, we do no need to comply with this request.

Advice and Guidance

Question B; We recognise that there may be public interest in the historic operation of the organisation and therefore offer the opportunity to have this search conducted upon the payment of a fee.

Based on the estimate of £40,500, less the £600 the organisation would spend on a FOI request, we calculate the fee to be £39,900.00
